Control Measures already in Place	PPE Required
1. Daily vehicle checks to ensure the vehicle has not been tampered with and a further quick check after returning from a short break.	Safety helmets <input type="checkbox"/>
2. Vehicles to kept locked and keys removed when unattended.	Hi-Vis Jackets <input checked="" type="checkbox"/>
3. Engine should be turned off if the driver is not in the cab.	Safety footwear <input type="checkbox"/>
4. Journeys should be planned in advance.	Eye protection <input type="checkbox"/>
5. Office staff to ensure the site address, site contact and arrival instructions are correct and provided to the driver before the start of the journey.	Dust masks <input type="checkbox"/>
6. Short-term stops should be within sight of your vehicle and longer or overnight parking should be at well-lit and secure locations.	Ear plugs <input type="checkbox"/>
7. Never load into another vehicle.	Earmuffs <input type="checkbox"/>
8. All deliveries/collections should match the paperwork.	Gloves <input type="checkbox"/>
9. Drivers to be aware of suspicious individuals, vehicles or locations.	Protective overalls <input type="checkbox"/>
10. All drivers should do the counter terrorism online training.	Gauntlets <input type="checkbox"/>
11. Mobile phones must be charged and available should an emergency arise.	Harnesses <input type="checkbox"/>
12. Vehicles should only be used on mainland UK unless authorised by the managing director.	Breathing apparatus <input type="checkbox"/>

Likelihood	
1. Very Unlikely	A freak combination of factors would be required for an accident/incident to occur
2. Unlikely	A rare combination of factors would be required for an accident/incident to occur
3. Possible	Could happen when accidental factors are present but otherwise unlikely
4. Likely	Not certain to happen but an additional factor may result in an accident/incident
5. Very Likely	Almost inevitable that an accident/incident would occur
Hazard Severity	
1. Negligible	Negligible injury, no absence from work
2. Slight	Minor injury requiring first aid
3. Moderate	Injury leading to a lost time accident
4. High	Involving a single person with a serious injury / death
5. Very High	Multiple persons with serious injury / death
Outcomes	
LOW	Score (1-6) May be acceptable. Annual Review to see if risks can be reduced further
MEDIUM	Score (8-10) Identify controls must be identified or specific method statement required
HIGH	Score (12-25) Task must not proceed. Senior Management to consider if the risks can be reduced by purchase of additional training, additional equipment, additional staff, additional signage, safe system of work, permit to work or radical changes in method.
